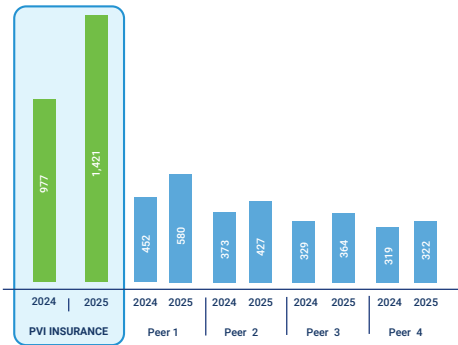

TOTAL ASSETS



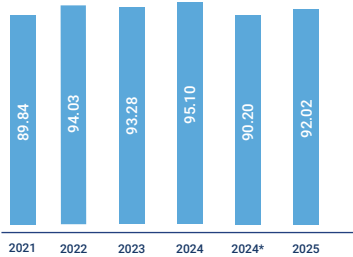
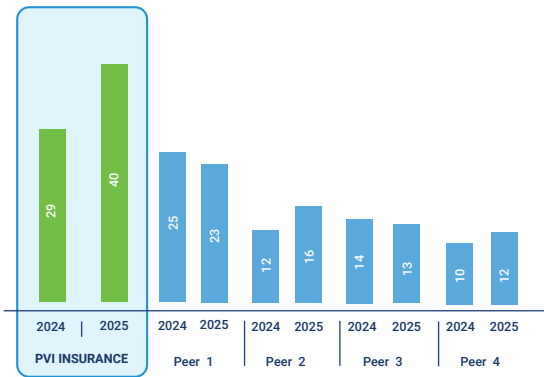

COMBINED RATIO (%)



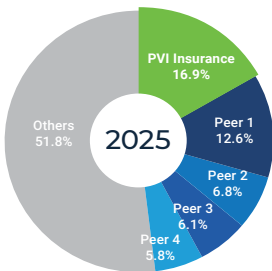
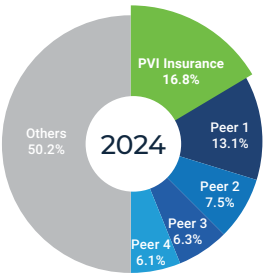
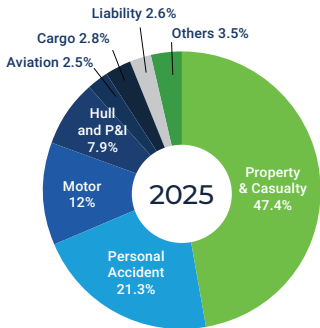
